## MEMBERSHIP CLASS DEFINITIONS

**Senior Voting:** Adults 21 years of age or older, married or single with children, with voting rights and Club privileges extending to their immediate family including unmarried children up to 25 years of age. Senior voting membership shall be entitled to one vote.

**Single Voting:** Adults 21 years of age or older, single, without a spouse or children, with voting rights and Club privileges extending only to that individual. Single voting members shall be entitled to one vote. Upon marriage, Single Members are required to convert to Senior Voting.

**Service:** Members of the United States Armed Services who are on active duty in the vicinity of Pascagoula, Mississippi, with single or family privileges as described above. These members shall have no voting privileges.

**Non-Resident:** Adults 21 years of age or older, single or married, residing outside of Jackson County. These members shall have no voting privileges.

**Legacy Senior:** Under the age of 25, married or single with children, who are dependents of a current member who is in good standing and has been a member, continuously, for the past 5 years. Club privileges extending to their immediate family including unmarried children up to 25 years of age. Legacy Senior membership shall be entitled to one vote.

**Legacy Single:** Single dependents, under the age of 25, of a current member who is in good standing and has been a member, continuously, for the past 5 years. Upon marriage, Legacy Single are required to convert to Lagacy Senior. Legacy Single shall be entitled to one vote

**Reinstatement:** Prior SRYC members who resigned in good standing and do not have outstanding fees due become a Reinstated member with a reduced initiation fee.
